**RESOLUTION**  
**MONTROSE COUNTY COLORADO**  
**APPOINTMENT OF**  
**DIRECTOR**  
**MONTROSE COUNTY DEPARTMENT HEALTH and HUMAN SERVICES**  
**and**  
**DIRECTOR PUBLIC HEALTH**

**WHEREAS**, the Board of County Commissioners of the County of Montrose, State of Colorado (hereinafter "the Board"), desires to make certain necessary administrative appointments pursuant to their duties and responsibilities as the governing body of Montrose County Colorado; and,

**WHEREAS**, Montrose County Colorado has established a public health agency, as set forth in Title 25, Art. 1, Colorado Revised Statutes, and a human/social services department as set forth in Title 26, Art. 1, Colorado Revised Statutes; the Montrose County Department of Health and Human Services ("DHHS"); and

**WHEREAS**, pursuant to §25-1-508(5)(c)(I) C.R.S., a board of county commissioners is to select a director of public health that meets certain minimum qualifications as set forth in 6 CCR 1014-6 to serve at the pleasure of the county board; and

**WHEREAS**, pursuant to §§26-1-115 and 26-1-117, C.R.S., a county board of social services is to appoint a county director of social services who is charged with the executive and administrative duties and responsibilities of the county department; and

**WHEREAS**, Kristin Pulatie has been found to meet the qualifications to serve as the Montrose County Director of Public Health and its County Director of Human/Social services; and

**WHEREAS**, the Board, also serving at the county Board of Social Services, wishes to designate and appoint Kristin Pulatie as the Director of the Montrose County Department of Health and Human Services; and

**WHEREAS**, such appointment and designation does not constitute a contractual obligation of the County of Montrose nor of the Board and the County and the Board are not legally bound for the respective term of appointment and designation as specified herein below, the County, by and through the Board, having the authority in its sole discretion, to change, add, or abolish such appointment and designation and to fill vacancies, therefore, as it sees fit.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MONTROSE, STATE OF COLORADO SETTING ALSO AS THE COUNTY BOARD OF SOCIAL SERVICES:**

**THAT** Kristin Pulatie has been found to meet the qualifications to serve as Director of the Montrose County Director of Public Health pursuant to Title 25, Art. 1 at §25-1-508(5)(c)(I) C.R.S. and 6 CCR 1014-6; and, be it further resolved,

**THAT**, Kristin Pulatie be and is hereby appointed **Montrose County Director of Public Health** for the term commencing as of the date of adoption and execution of this Resolution until further order of the Board, in accordance with §25-1-508(5)(c)(I) C.R.S. and 6 CCR 1014-6; and,

**THAT** Kristin Pulatie possesses the education and experience to serve as the Montrose County Director of Human/Social Services pursuant to Title 26, Art. 1, §§26-1-115 and 26-1-117(1), C.R.S.; and

**THAT**, Kristin Pulatie be and is hereby appointed **Montrose County Director of Health and Human Services** for the term commencing as of the date of adoption and execution of this Resolution until further order of the Board, in accordance with such statutory requirements; and

**THAT**, the Board hereby finds, determines and declares that this **RESOLUTION** is necessary for the public health, safety and welfare of the residents of the County of Montrose, State of Colorado; and

**THAT** this appointment does not constitute a contractual obligation of the County of Montrose Colorado nor its Board; nor constitute a defined term of employment of the appointee; and the County, by and through its Board has authority, in its sole and absolute discretion to amend, revise, change, add or abolish the appointment and designation encompassed in this Resolution as seen fit.

**MOVED, READ, and ADOPTED** by the Board of County Commissioners of the County of Montrose, State of Colorado also setting as its County Board of Social Services, at its Board of County Commissioners public meeting effective this the seventeenth day of August, 2015.
